Minutes: BOD (Board of Directors) and BOG (Board of Governors) meeting July 27, 2011. THIS WAS AUGUST 2011 BOD/BOG.

The meeting was called to order by President Mishenko at 1020.

Discussion:

1. Received a \$200.00 donation from Midwy USA for our youth activities programs. Sec to draft an LOA. The package put together to request support from Midway worked.
2. Sec has three rebate checks for the treas.
3. LAFRA feeding in support of Nutrition month successful. Well done Ladies!
  - a. 42 were fed in East Dirita and 43 were fed in West Dirita
4. Pres, VP and Sec as well as LAFRA Pres, past pres met with the Mayor of San Antonio to discuss possible community service projects in the area by US Navy ships in Subic.
5. Pres, VP and sec met with Chaplain Rinaldi and ships Doctor from USNS Frank Cable to discuss and plan future COMSERV projects that the area veteran service organizations (FRA, VFW, Clark Veteran's Cemetery) are working on. We hoe to get the collective group of veteran's organizations on the accepted state department list for projects in Philippines. We'll see what happens.
6. Discussed keeping a running list of comserv projects that can be acted upon with minimal notice.
7. We still need a PAO but finding a volunteer who can write and take pictures is rather difficult. We have been looking for one for a number of years.
8. Roof repairs: the never-ending roof problems discussed and acted upon.
9. MOTION Doty, SECOND Randolph to provide P15,000 for roof repair materials. Handyman Roger will do the work. APPROVED. This needs GMM vote.

10. Electrical problems: next on the repair priority list is to get the feeder line and the interior wiring repaired. We will work this after repairing the roof and when we have the money to do it. Circuit breaker box needs replace and all breakers replaced. We plan to repair one circuit per month as we have the funding. The fire marshall actually commented on our very old wiring.
